### 1 INFORMATION WE COLLECT FROM YOU

We will collect and process the following data about you:

- 1.1 **Information you give us.** This is information about you that you give us by filling in forms on our site [www.vigilanceprotects.com](http://www.vigilanceprotects.com) (our site) or by corresponding with us by phone, e-mail or otherwise. It includes information you provide when you register to use our site, subscribe to our service, search for a product, place an order on our site, participate in discussion boards or other social media functions on our site, enter a competition, promotion or survey, and when you report a problem with our site. The information you give us may include your name, address, e-mail address and phone number, financial and credit card information, personal description and photograph.
- 1.2 **Information we collect about you.** With regard to each of your visits to our site we will automatically collect the following information:
